

# SAN DIEGO DERBY DOLLS

## SPECIAL EVENT // PARTICIPANT CODE OF CONDUCT



All visitors to the hosting facility and Events are responsible for their behavior and are expected to adhere to all policies, rules, and expectations outlined for all Roller Derby 360 (RD360) dba. San Diego Derby Dolls (SDDD) activities and facilities. Visitors are held individually responsible for the decisions they make regarding their behavior. This code of conduct applies equally to skaters, officials, volunteers, juniors and parents.

The rules, policies and procedures of RD360 are there for the safety of all participants. Any conduct on the part of a visitor that has or might reasonably have an adverse effect on the proper functioning of RD360 and the host league -- or the health, safety, rights or property of the host league, its members, volunteers, or fans-- is subject to complete removal and prohibition from any league Facilities and/or league related activities. RD360 has Zero Tolerance for any breach of the standards outlined below.

It is expected that:

- Participation as a visitor to the host facility and/or its events implies acceptance by every visitor of the principles of mutual respect for the rights, responsibilities, dignity and well being of all others.
- All visitors will conduct themselves in a manner that respects these principles when participating in league activities and/or facilities.
- All visitors will adhere to all host league policies, procedures and rules.

It is acknowledged that participation as a visitor to the host RD360 facility and all RD360 Events is a privilege, which comes with the following understanding:

NO VISITOR SHALL: At any time hit, push, shove, strike or threaten to strike a skater, volunteer, referee or spectator.

NO VISITOR SHALL: Use unnecessarily rough tactics (ie. Intentionally hit with malice which is not the result of legal play) against the body and/or person of any other skater, referee, or volunteer.

NO VISITOR SHALL: Abusively and verbally attack any player, official, spectator or agent associated with the host league or the RDCL.

NO VISITOR SHALL: Be on the track at any time in an intoxicated condition of any kind (ie. Having consumed alcohol, drugs or prescription medications of any kind, which may affect judgment or motor skills).

NO VISITOR SHALL: Discuss in a defamatory, libelous or abusive manner in any public forum, about any play, decision, or his/her personal opinion of other players or league members of the host league or RD360. However, this does not include league member sassiness between players or spectators, as long as she/he keeps banter and behavior light-hearted, non-abusive and non-derogatory.

ALL VISITORS SHALL: Encourage and promote friendly relationships and good sportsmanship by showing courtesy and proper decorum. Any complaints or disagreements should be addressed to designated host or RD360 representatives who handle such complaints. No officials or tournament staff may discuss disagreements in a public forum.

ALL VISITORS SHALL: Comply with all host league rules and regulations. All Dollhouse public events are family friendly and must be presented in a PG manner. Audible swearing, obscene gestures, mooning and other inappropriate adult behavior will not be tolerated at any public event/activity and participants may be immediately removed from competition.

ALL VISITORS SHALL: Comply with all safety rules and regulations for all activities, including proper equipment for all participants and safety for spectators. All medic safety calls are final and will be honored by Head Ref and tournament staff.

**MEDICAL:** It is the responsibility of the undersigned to ensure that the above named person is medically fit to participate in strenuous on-rink or off-rink activities. As stated below, participation in roller derby activities presents an inherent risk of injury to person or property. The undersigned certifies that the above named participant has no known conditions that prohibit or limit participation in any derby/skating activities held by or in association with roller derby events. Participant skates at own risk and is solely responsible for all insurance coverage. Participants certify that they have adequate insurance to cover any injury or damage they may cause or suffer while participating in, or activities associated with on-rink or off-rink activities. **It is required by Roller Derby 360 LLC (San Diego Derby Dolls) & SoCal Derby LLC that all on-skates participants carry their own personal medical and/or accident insurance.**

**EQUIPMENT AND SKATES:** Participants must wear the following mandatory safety equipment during all on-rink activities and practices: Knee, Elbow and Wrist Pads, Helmet and Mouth Guards. Eyeglasses must have plastic shatterproof lenses. The undersigned must take full responsibility that the above named participant (including self) is wearing the aforementioned safety equipment at all times while on skates and that it is properly worn.

**INSTRUCTION:** The training, opinions, findings, and conclusions offered are the speakers and do not imply medical expertise or acceptance of any liability. The materials and information presented are for informational purposes only & are not legal advice or counsel. Information gathered should be modified to fit your own personal needs, athletic competence, limitations, and state requirements. All skaters should execute proper safety precautions prior to attempting any skills demonstrated or shown. All participants skate solely at their own risk.

**MEDIA:** Members and visitors to the Dollhouse may be photographed or videotaped at anytime in connection with their participation in roller derby practices and events. The undersigned grants Roller Derby 360 LLC & SoCal Derby LLC the right to use their likeness in connection with their participation in Roller Derby 360 LLC & SoCal Derby LLC events in all media, whether now known or hereafter devised, throughout the universe in perpetuity without compensation, reservation or limitation.

**CONDUCT:** Spectators (patrons on the premises as a result of your involvement in the roller derby) as well as participants must behave in a respectful manner to both person and property. Behavior which could potentially lead to intentional or unintentional bodily injury or injury to property will lead to immediate removal from the facility.

**INDEMNIFICATION AND RISK ACKNOWLEDGMENT:** In consideration of being allowed to participate in any way in roller derby athletic sports programs, related events and activities in any way connected with my participation in, or activities associated with, this activity, or my use of Roller Derby 360 LLC and SoCal Derby LLC equipment or facilities, including any such claims which allege negligent acts or omission of Roller Derby 360 LLC and SoCal Derby LLC, the undersigned acknowledges, appreciates and agrees that:

1. The risk of injuries from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment and personal discipline may reduce this risk, the risk of serious injury remains; and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and I assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY VOLUNTARILY RELEASE, FOREVER DISCHARGE, AGREE TO INDEMNIFY, DEFEND ON DEMAND AND HOLD HARMLESS ROLLER DERBY 360 LLC, SAN DIEGO DERBY DOLLS and SOCAL DERBY LLC their venues, coaches, skaters, officers, officials, agents, and/or employees, other participating skaters and officials, sponsoring agencies, sponsors and advertisers ("RELEASEES") WITH RESPECT TO ANY AND ALL CLAIMS, DEMANDS, CAUSES OF ACTION, INJURY, DISABILITY, DEATH, or loss, or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
5. I, for myself and on behalf of my heirs, give permission to the league to authorize emergency medical treatment as it may be deemed necessary by Company for Participant. I HAVE READ THIS ASSUMPTION OF RISK AGREEMENT AND I ACCEPT RESPONSIBILITY; I FULLY UNDERSTAND ITS TERMS, AND I UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND I SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
